

## NOTICE TO BIDDERS

Notice is hereby given that the Board of County Commissioners of Okaloosa County, FL, will accept sealed bids until **3:05 p.m. (CST) ~~September 4th, 2014~~ September 11, 2014**, for the **Tanglewood/Overbrook Stormwater Management Improvements Grant in Okaloosa County**. Cost of documents will be One Hundred dollars (\$100.00) per set, non-refundable – checks to be made payable to “Okaloosa County BCC.”

At **3:05 p.m. (CST), ~~September 4th, 2014~~ September 11, 2014**, all bids will be opened and read aloud. All bids must be in sealed envelopes reflecting on the outside thereof the Bidder's name and "**Bid on Tanglewood/Overbrook Stormwater Management Improvements Grant in Okaloosa County to be opened at 3:05 p.m., September 4th, 2014**". The Board of County Commissioners will consider all bids properly submitted at its scheduled bid opening in the **Conference & Training Room #305 – (old First National Bank Bldg.)** located at 302 N. Wilson St, Crestview, FL 32536. Bids may be submitted in the Conference & Training Room #305 prior to bid opening or delivered to the Clerk of Circuit Court, 302 N. Wilson St., #203, Crestview, FL 32536. **NOTE: Crestview, FL is not a next day guaranteed delivery location by most delivery services.** Proposers using mail or delivery services assume all risks of late or non-delivery.

A mandatory pre-bid meeting will be held at **2:00 p.m. on Tues., August 26th, 2014**. The meeting will be held at the Okaloosa County Department of Public Works Conference Room at 1759 S. Ferdon Blvd Crestview, FL 32536 (850) 689-5772.

The County reserves the right to award the bid to the lowest responsive Bidder and to waive any irregularity or technicality in bids received. Okaloosa County shall be the sole judge of the bid and the resulting negotiating agreement that is in its best interest and its decision shall be final.
