This addendum is to provide the list of attendees of the mandatory pre-bid conference and to answer questions submitted by the vendors.

Questions and Responses:

- 1) Will you post the pre-bid attendance list? **See attached.**
- 2) Can arrangements be made for additional inspection of the vessel, prior to bid time? **Yes, this can be arranged, if needed. Additionally, Hurlburt Field staff can be contacted at 850-881-5282 for vessel questions.**
- 3) Is a bid bond required with the bid package? **No.**
- 4) Is a payment and performance bond required as part of the contract? **No.**
- 5) Can the contractor salvage and/or repurpose the vessels mechanical and electrical equipment (engines, generator, electronics, etc.)? **Yes.**
- 6) Can the contractor salvage and/or repurpose hatch covers and doors (leaving a cut hole in the location of hatch or door)? **Yes.**
- 7) Can the contractor salvage and/or repurpose windows (leaving a cut hole in the location of windows)? **Yes.**
- 8) Can the contractor salvage and/or repurpose the vessels fuel and oil tanks? **Yes.**
- 9) Does the vessel contain any asbestos? **To our knowledge, there is not. It would have been dealt with during the last retrofit**
- 10) Does the vessel contain any lead paint? **To our knowledge, there is not. It would have been dealt with during the last retrofit**
- 11) Is any preparation required to the anti-fouling paint on the hull? If so, to what extent? **No.**
- 12) How much fuel is on the vessel? **<500gal**
- 13) How much oil is on the vessel? **Engine oil and <20gal in container mounted on bulkhead.**
- 14) Is there sewage in the holding tank? If so, how much? **1 tank. ~60gal**
- 15) Does the vessel's rubber fendering need to be removed? **Yes.**
