General Session Overview of Topics

Okaloosa Sheriff Marine Patrol – Sgt. Kyle Corbitt (15 minutes)

The Marine Patrol will cover BUI enforcement, County Ordinances, Boating Safety Regulations, and Idle Speed/No Wake Zone Violations.

Florida Fish and Wildlife Conservation Commission (FWC) - Lt. Bartlett (15 minutes)

Representatives will discuss basic livery regulations and address common violations observed each year.

U.S. Coast Guard – CDR Dan Kilcullen, Senior Chief Palmer & Lt. Steve Browning (15 minutes)

Items to be addressed are boater safety, the Coast Guard station in response to search and rescue, Coast Guard inspections, environmental response and investigations, and illegal charters and bareboat charters.

National Park Service – Richard Devenney (10 minutes)

NPS will provide an update on the planning process and commercial operations at Crab Island.

Okaloosa County Watersport Operators Coalition – John Stephens (10 minutes)

The Okaloosa County Watersport Operators Coalition will highlight their boater education video series, and share about safety initiatives including Safety Stickers, Wrist Band System and GPS/No Wake Zone Alarms.

Coast Guard Auxiliary - Doug Ritchie & Larry Messinger (10 minutes)

The Coast Guard Auxiliary will discuss prevention efforts including the wearing of PFD's and free vessel safety checks/exams; livery vessels and commercial "6 pack charter" UPVs; and the Paddle Craft Safety Initiative (AUXPAD).
