REQUESTED VARIANCE: 559057-BOA-2024 Marisol M. Fernandez – a variance request from Section 6.05.021 Perimeter Requirements of the Okaloosa County Land Development Code, Ordinance 91-1 as amended. The request is from the required ten (10) foot wide perimeter landscape area along the west boundary line adjacent to Lake Avenue, from 10' to 0' for the proposed Family Shopping Center, due to a 25' wide right-of-way donation as required by the Okaloosa County Public Works Department. The property is currently zoned Mixed Use (MU) with a Future Land Use Map (FLUM) designation of Mixed Use (MU). The property is located at the northeast corner of US Hwy 98 West and Lake Avenue, Mary Esther, Florida and contains 0.86 acres more or less.
