The County previously established a Vessel Exclusion Zone in an area of heavy vessel congestion at Crab Island to allow an unobstructed corridor for emergency vessels. Over time this zone has become inefficient and unnecessary as a majority of the local emergency vessels no longer utilize this zone. This ordinance seeks to repeal the Vessel Exclusion Zone and open up the area to all vessels.
