

Okaloosa County Public Works crews are always busy. This asphalt crew was recently making some final touches to Kilcrease Road in Baker during paving operations.






A caring community

Progress Continues on the Bridge-to-Bridge Multi-use path on Okaloosa Island. The UF/IFAS Extension Northwest District team held an inaugural Farm to Well Summit on February 4, 2025 in Pace, Florida. The Farm Well Summit brought together farmers, partners, and Extension Agents across the panhandle to discuss farmer mental health and resources to support our communities. Okaloosa County Commissioner, Carolyn Ketchel, was the keynote speaker. Commissioner Ketchel shared a memorable address highlighting the importance of mental health in the agricultural and aquaculture communities and how to get help. All Farm Well Summit participants who completed a post-event survey indicated the event increased their awareness of mental health challenges and confidence about addressing mental health issues in farming communities. There were 88% of participants who shared they would use strategies and insights from the Farm Well Summit in their work or personal life.

DID YOU KNOW?

According to Florida law, tourism revenue collected from short-term rental lodgings can **ONLY** be used for tourism-related investments. This includes things like public safety, tourism promotion, beach and marine conservation/ecotourism and parks.

Tourism revenue **CANNOT** be used for road and stormwater improvements. Fortunately, our voter-approved infrastructure surtax has helped with those improvements. And guess what? Tourists pay both when they spend money during their visit.

Why is tourism important for Okaloosa County?

Tourism impacts the local economy in many ways; by creating jobs, contributing to sales tax, infrastructure surtax, contributing to small business revenue, and in our countywide tourist development district, they also fund tourism-related amenities, activities, environmental improvements, protection, restoration and preservation.
