The Project consists of clearing and grubbing, grading and excavation, construction of ponds, construction of stormwater berms and ditches and structures, pavement patching, sodding, and other WORK as shown on the construction drawings and described in the specifications to construct stormwater improvements. The work is further defined as shown on the Plans and as described by the Contract Documents.

The County reserves the right to award the bid to the lowest responsive respondent and to waive any irregularity or technicality in bids received. Okaloosa County shall be the sole judge of the bid and the resulting Agreement that is in its best interest and its decision shall be final.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form. All terms, specifications and conditions set forth in this ITB are incorporated into your response. A bid will not be accepted unless all conditions have been met.
