2. Military Vendors and Partnerships

Eglin AFB reported that they have a 43% recycling rate and Hurlburt AFB reported a rate of 22.4%.

3. Gold Star program with all Chambers of Commerce participation

The Chamber needs a model before going forward with a program. Several businesses in the area such as Firestone, Batteries Plus and Best Buy provide recycling services even if you haven't made a purchase from them.

4. Choctawhatchee Basin Alliance

Director Alison McDowell said that the CBA provides 1 hour per month with students focusing mainly on clean water and she doesn't know if they can fit anything else in that tight schedule. During beach cleanup they could emphasize recycling as a way to reduce debris in the waterways.
